- Moenie die toegelate hoeveelheid gaste per chalet (4 persone), houthuis (6 persone) of kampplek(6 persone) oorskry nie.
- Slegs 2 voertuie per chalet, houthuis en staanplek word toegelaat. Hou die voertuie asseblief op die perseel wat aan u toegestaan word.
- Spoedgrens vir die kampeerterrein op alle paaie is 20km/h.
- Geen persone, behalwe betaalde gaste mag van enige fasiliteite by Goudmyn gebruik maak nie.
- Geen rook in akkommodasie of ablusie geriewe nie.
- Stiltetyd is 22:00. Alle gaste moet dit asseblief respekteer.
- Geen partytjies indien dit nie vooraf gereël is nie.
- Ons verskaf braaidromme, bring eie rooster.
- Kampeerders gebruik blou kragproppe., kan gehuur word indien dit vooraf gereël word.
- Geen waterponies of ski bote nie.
- Slegs bote met minder as 10 perdekrage vir visvang word op eie risiko toegelaat.
- Kano's, kajakke en roeibote word op eie risiko toegelaat.
- Die skoonhou van privaat ablusiegeriewe is die kampeerder se eie verantwoordelikheid.
- Indien die ligte saans aan is, hou alle vensters en deure toe vir ongewenste insekte.
- Alle fasiliteite word op eie risiko gebruik.
- Reg van toegang voorbehou.
- Enige persoon wat nie hieraan voldoen nie, sal versoek word om die perseel te verlaat sonder enige vergoeding.
- Geen terugbetaling van deposito's.
- n Maand en langer kennisgewing kan n bespreking geskuif word.

RULES

- No day-visitors are allowed.
- No pets allowed.
- No music.
- Your children are your own responsibility at all times.
- Please don't drink any water on the farm. The chalets and wooden cabin do have drinking water.
- Do not exceed the maximum guests allowed per chalet (4 persons), wooden cabin (6 persons) or campsite (6 persons).
- Only 2 vehicles per chalet, wooden cabin or plot will be allowed. Please park on the premises that is allocated to you.
- Speed limit for the campsite on all roads is 20 km/h.
- No persons, except paying guests, may use any of the facilities at Goudmyn.
- No smoking inside accommodation or ablution facilities.
- Please respect your fellow guests and keep quiet after 22h00.
- No parties are allowed without prior arrangement.
- We supply portable braai facilities. Therefore bring your own grid.
- Campsites only use blue camping plugs. Available to hire from the office at an additional cost.
- No jet ski's or ski boats are allowed.
- Only boats with less than 10 horsepower engine will be allowed on the river at own risk.
- Canoes, kayaks and rowboats are allowed at own risk.
- It is your own responsibility to keep your private ablution clean.
- Please keep windows and doors closed at night when lights are on, this will keep unwanted insects outside.
- All facilities to be used at own risk.
- Right of admission reserved.
- Anyone not complying will be evicted without any re-imbusement.
- No refund of deposits.
- More than one month notice we will reschedule bookings.

I, the undersigned, so hereby acknowledge having received a copy of the rules of Goudmyn which I have studied. I declare myself fully conversant with and do hereby undertake to comply with these rules. I furthermore take note of an unfenced river on the property and do accept irrevocably full accountability for the safety of myself, my wife, my children and any other person in the chalet, wooden cabin or camp site allocated to me.
